Reinforcing coils K500A-WR, K500AB-WR, K500B-WR and K500C-WR are aimed to be used in concrete structures. This certificate is based on an initial type assessment of the product (test reports EUFI29-24004877-T1) and an initial inspection of the factory production control (inspection report EUFI29-24004452-I2) according to the certification criteria R080. According to the results K500A-WR, K500AB-WR, K500B-WR and K500C-WR reinforcing coils can be used as reinforcing bars at concrete structures.

Parallel ribs at equal spacing on three sides is rolled to the coils. A rolled identification mark of the producer "6/11".

The product should be delivered with durable label. Attestation of conformity, identification number granted by the certification body, product specification, stainless steel designation number, technical class, nominal diameter, coil weight, batch or cast number, manufacturer, and manufacturing location.
